PROSPECTUS

ELIGIBILITY:

Open to all artists in Northern California and Southern Oregon who are 18 years of age or older.

ACCEPTABLE WORK:

Two dimensional art in all mediums except film or digital photographs. Digital art is acceptable.

PROVISIONS:

1. No student work or workshop art will be allowed.
2. No reproductions or copies will be allowed. All artists must sign the Statement of Originality and Artist Release on the entry form.
3. All art work submitted must be ready for hanging. Properly framed with wire hangers. Museum wrap is acceptable but the sides of the art must be painted to conform to the art.
4. A label with the artist name, address, phone number, title, medium and price must be attached to the back of the art.
5. Artwork must have been created within the last two years.
6. Art work that is deemed unacceptable will not be allowed.
7. All selected works will not be released before the close of the exhibit.

LIMITATIONS:

Three works of art may be submitted not exceeding 40.0" in any dimension, including frame. Any entries exceeding this dimension will not be accepted.

ENTRY FEES:

\$15 for the first entry, \$10.00 for additional entries.

AWARDS:

First Place..... \$500
Second Place \$300
Third Place \$200

Four Honorable Mentions will be given at the discretion of the jurors.

THURSDAY September 4, 2008

Art will be juried and the show will be hung. Those artists whose work was not accepted will be notified by phone or by eMail.

SATURDAY September 6, 2008

An opening reception will be held at the gallery from 6 p.m. to 8 p.m. Awards will be announced at the reception.

TUESDAY September 30, 2008

Exhibit closes. All art work must be picked up at the gallery between 11 a.m. and 4 p.m.
