An Art Exhibition for Seniors at the Del Norte County Fair: Aug. 1-4, 2019

Prospectus

Eligibility: All northern California and southern Oregon seniors (65+).

Provisions:

1. No group work, copies, projections or work that has been partially or totally prepared by any commercial printing process may be submitted (the exception to the latter is photography, which is welcome).
2. Submitted items must be dry, suitably framed (if applicable) and wired ahead of time for hanging. The hanging apparatus needs to be picture wire suitable for the weight of the piece mounted on the back, stretched fairly tightly between two eye screws on either side of the frame or work.
3. A label with the artist's name, address, phone number, title and medium needs to be on the back of the art.
4. Submission of artworks to this show constitutes an agreement to all the conditions set forth in this prospectus and entry form (see attached), including permission to reproduce the artworks for publicity purposes.
5. **No art will be released before the take down of the exhibit, i.e., before 11:30 a.m. on Mon., Aug. 5.**

Limitations:

1. Two- and three-dimensional media are welcome; 2-dimensional pieces should be no larger than 50" per side.
2. No more than three (3) entries per artist may be submitted.

Entry Fees & Commissions:

1. The nonrefundable entry fee is \$10 per entry.
2. A 25% commission is requested from the artist on all sales. All checks should be made payable to DNACA.

Registration:

1. The deadline for your **entry form** is 5 p.m. on Friday, July 26, 2019.
2. Completed forms and fees should be postmarked no later than **Friday, July 26** (our mailing address is P.O. Box 1480, Crescent City, CA 95531) or may be emailed to dnaca_cc@icloud.com; if you choose to email us your entry form, please note that you will need to bring your entry fee with the artwork.

Judges/Awards:

1. The show will be judged by two professional, regional artists of varying media who are independent from our organization.
2. Modest cash awards (commensurate with the number of entries) and ribbons will be given for first, second and third place. Up to five (5) honorable mentions may also be given at the discretion of the judges.

Delivery/Pick up of Artwork:

1. Artwork should be **delivered** to the Floral Building at the Del Norte County Fairgrounds, 421 North Highway 101 in Crescent City, **between 11:30 a.m. and 1 p.m. ONLY(!) on Tuesday, July 30. Works brought in at other times will not be accepted.**
2. All items must remain up for the duration of the fair, and need to be **picked up in the same location between 11:30 a.m. and 1 p.m. (ONLY!) on Monday, August 5.** For other arrangements, call 464-1336 in advance.
